## Qualifications to Become A CARO Judge

### SUBMIT APPLICATION

- Be a Professional Member of CARO in good standing. (Current)
- Enclose \$25.00 ( PLUS GST/HST) Application Fee payable to CARO

### JUDGE'S TEST

The Judge's Test will be sent to the applicant upon fulfillment of the requirements to the right

### REQUIREMENTS

- Have obtained a CARO Advanced title
- Have participated in an **approved** CARO judging clinic :
- Must shadow judge under an approved CARO judge for 10 courses. 10 dogs minimum at each level. Team requires 5 teams at each level
- 2 Novice    2 Advanced    2 Excellent    2 Novice Team    2 Advanced Team

### SHADOW JUDGING

- The required courses may be obtained at one trial or spread out over several separate trials and/ or fun Matches.
- The name of the Judge(s) with whom you will be shadow judging, must be submitted to CARO

A list of approved judges can be obtained from CARO

The name of the Judge(s) with whom you will be shadow judging, must be submitted to CARO

A written test for Novice/Advanced/Excellent will be sent to applicant upon submission and fulfillment of the above requirement.

A separate application must be submitted to receive the test for Versatility.
