Entry Process & Requirements

- Dogs must have a [DOG CARO ID number](#) before Sept. 4th, 2022.
- CARO memberships must be in good standing as at Sept. 4th, 2022 to be eligible for member discounts.
- Accommodation requests should explain the physical challenge and the modification(s) requested.
- Upon receipt of confirmation:
 - DO NOT reply to the confirmation message or email the trial secretary unless answering or asking a question.
 - All payments must be made online via PayPal Only - <https://canadianrallyo.ca/page/paypal>
 - DO NOT submit payment prior to receiving confirmation of entry.
 - Upon receipt of the confirmation of entry payment is due within 24 hours.
- Note that there is a limit of 4 runs per dog in the regular classes (A/B and C stream entries).
 - This cap does not apply to Team, Brace and Working entries.
- Team entries - include the name and CARO dog registration number of the partner team.

Move Ups

- General Classes – move ups are allowed.
- Working classes – move ups are allowed for the exercises that the competitor has registered for. Competitors may not change exercises.

Health and Safety

- Participants are expected to follow all health and safety protocols and leash laws in their areas when recording.
