Entry Process & Requirements

- Dogs must have a CARO dog registration number by August 23, 2025.
- CARO memberships must be active and in good standing as of August 23, 2025 to qualify for member discounts.
- Accommodation requests should be included with the entry form and detail the physical challenge, and the specific modification(s) needed.
 - Late accommodation requests submitted after course maps are released will only be considered in cases of unforeseen events or (handler) injury. These late requests are granted at the judge's discretion and must be discussed directly with the respective judge(s).
- Team entries - include the name and CARO dog registration number of the partner team.
- Team & Brace entries - both partners must submit an entry form.
- Bye Dog entries - submit separate forms for bye dog and regular entries.
